

NOTICE OF ORDER

HIGHWAYS ACT 1980

Essex County Council
Public Path Diversion Order 2017 Footpaths 5 and 18 Clavering in the
District of Uttlesford.

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **04 July 2017**

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be a part length of Footpath 5 Clavering commencing from grid reference 54639,23468 on the parish boundary where it connects with Footpath 10 Arkesden and running in a south westerly direction for a distance of approximately 122 metres to grid reference 54630,23460 where it connects with Footpath 7 Clavering, then continuing as Footpath 18 in a southerly direction for a distance of 40 metres to north of the barn at Clavering Farm at grid reference 54630,23455 is being diverted to a new alternative route commencing from the same above point running across the existing footbridge in a westerly direction along the field boundary on the north side of the hedge for a total distance of approximately 173 metres to grid reference 54622,23469 where it connects to the new section of Footpath 7 Clavering.

Any person wishing to view the statements of case and other documents relating to this Order may do so by appointment at The Definitive Map Service Department, A2 County Hall, Market Road, Chelmsford, Essex, CM1 1QH during normal office working hours.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date by 18 July 2017

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date by 29 August 2017

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date 10 October 2017

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpaths described in paragraph 1 of this Order it is expedient that the line of the paths should be diverted.

The Applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order, the expenses incurred in the order making and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.


Uttlesford District Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public rights of way over the land situate at The Moat House known as Footpaths 5 and 18 Clavering in the District of Uttlesford and shown by a bold continuous line on the order map numbered CLAV 18 K contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.

2. There shall at the end of 28 days from the date of confirmation of this Order be a public footpath over the land situate at The Moat House in the District of Uttlesford described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered CLAV 18 K contained in this Order.

DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS


A part length of Footpath 5 Clavering of unknown width shown by a bold continuous line on the order map commencing from point **M** at grid reference 54639,23468 on the parish boundary where it connects with Footpath 10 Arkesden running in a south westerly direction for a distance of approximately 122 metres to point **B** at grid reference 54630,23460 then continuing as Footpath 18 Clavering in a southerly direction for a final distance of approximately 40 metres to point **K** north of the barn at Clavering Farm at grid reference 54630,23455.

[PART 2]
DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the Order map commencing from the aforementioned point **M** running in a westerly direction across the existing footbridge and along the field boundary on the north side of the hedge for a total distance of approximately 173 metres to the aforementioned point **D** at grid reference 54622,23469 where it connects to Footpath 7 Clavering.
