In this context, “significant” means experience covering all or most of the activities below in more than two or three cases.

- Advising on the merits of judicial review proceedings
- Drafting written instructions for counsel to represent a client in proceedings
- Drafting witness statements and skeleton arguments
- Preparing hearing bundles
- Drafting pre-action protocol letters
- Gathering evidence
- Assessing whether a client will qualify for Legal Aid applications and dealing with other costs related to judicial review applications.

Alternatively, applicants may have significant direct experience of performing these activities in the context of ordinary civil litigation. The Commissioner will also consider experience of carrying out some of these activities in relation to particularly complex OISC Level 3 cases, but this should be combined with experience of Judicial Review Case Management or ordinary civil litigation.

Applicants should provide a list of relevant cases worked on, including dates of instruction and details of outcomes where possible; also details of counsel instructed.

Evidence may take the form of verifiable references from former employers, supervisors and/or instructed counsel; verifiable samples of work; or a combination of the two. The Commissioner may make enquires to verify any information or corroborate evidence. The Commissioner may request further evidence where necessary.
