<p>Tuberculosis screening 肺结核检测</p>	<p>If you are a person from a country listed in Appendix T Part 1 making an application for entry clearance to come to the UK for more than six months, you must present, at the time of application, a valid medical certificate issued by a medical practitioner listed in Appendix T Part 2 confirming that you have undergone screening for active pulmonary tuberculosis and that this tuberculosis is not present. 如果您来自移民法规附表T第1小节中列出的国家, 并且申请在英国停留超过6个月, 则必须在递交签证申请时提供由附表T第2小节中列明的从业医生开具的有效健康证明, 用于确定您进行了开放性肺结核筛查并且未患有肺结核。</p>

Sponsor 担保方

Tier 2 (General) is for people coming to the UK with a job offer to fill a gap that cannot be filled from within the resident labour force. It is also for applicants coming to fill shortage occupations.

第二层级（普通类）适用于获得工作机会前往英国填补工作空缺的人，并且该空缺无法被当地劳动力市场所填补。该类别同样也适用于填补当地短缺职位的申请人。

Before you apply under this category, you must have:

申请此类签证前，您必须有：

- a sponsor; and 一个担保方；以及
- a valid certificate of sponsorship. 一份有效的担保证书。

The certificate of sponsorship will act as an assurance that you are able to undertake a particular job and intend to do so. Your sponsorship is confirmed in your certificate of sponsorship. You must give your certificate of sponsorship reference number when you apply. 该担保证书用来担保您能够胜任特定工作，并且计划接受该工作。担保证书中会说明您的担保情况。您在申请签证时需提供担保证书号码。

You will then be able to enter the United Kingdom for up to 14 days before the start date for the job shown on your Certificate of Sponsorship.

您最早可以在担保证书中显示的工作起始日期前14天进入英国。

Salary and allowances 工资和津贴

Confirmation that you will be paid an appropriate salary and allowances for the job that you will be doing in the UK
一份证明，说明您会通过英国从事工作获得合理的工资和津贴

You should ask your sponsor to confirm, on your certificate of sponsorship, the salary and allowances for the job. 您应要求担保方确认您的担保证书中列明工资和津贴。

Limit on Tier 2 (General) workers applying from abroad
第二层级（普通类）海外申请人限额

For the year from 6 April 2014 to 6 April 2015, a maximum of 20,700 skilled workers can come to the UK under Tier 2 (General) to do jobs with an annual salary below £153,500. 2014年4月6日至2015年4月6日，年薪低于15.35万英镑，申请第二层级（普通类）签证的技术人员最高限额为20,700人。

There is no limit on the number of workers coming to the UK to do jobs with an annual salary of £153,500 or above.

对年薪15.35万英镑或更高的工作者不设限额。

English language ability 英语语言能力

Proof of your English language skills you must send to support your application. 需和申请一起提交的英语语言能力证明

If you are a national of a majority English speaking country (as specified in the Immigration Rules), you can meet the requirement by sending your current original passport or travel document.

如果您是以英语为主要语言的国家（移民法规中有特别指出的国家）的公民，可以通过提交当前的护照或旅游证件原件证明您满足我们的语言要求。

You can also meet the requirement by providing documentary evidence that you have passed an English language test with an approved provider at or above level B1 of the Common European Framework of Reference (CEFR). The test and provider must be on our list of [approved English language test providers](#). This evidence should contain your test results - for example, an original academic certificate of award for IELTS.

您也可以递交材料证明您已通过认可的机构提供的英语语言测试，并且成绩达到《欧洲语言共同参考框架》(CEFR)B1或以上水平。此类测试及其提供机构必须在获得我方认可的[英语语言测试机构名录](#)之中。此类证明应包含您的测试成绩，例如：雅思 (IELTS) 成绩单原件。

If you have a degree completed in English or undertaken in a country where English is the main language, you can meet the requirement by providing your original academic certificate of award. If your degree was not taught in a majority English speaking country and is not listed on our points calculator, you must provide:

如果您获得的学位使用英语授课，或在以英语为主要语言的国家完成学业，您可以递交相应的学历证书原件证明您符合要求。如果您持有的学历是由非英语为主要语言的国家授予，并且无法在计点积分计算器中找到，您则必须提交：

- an original letter and/or certificate from UK NARIC confirming the equivalent level of your degree course; and 英国国家学术认证信息中心 (UK NARIC) 的信函以及/或者证书原件，确定您的学位课程的相应等级；以及
- a letter from the academic institution that awarded the qualification. 学历授予机构的证明信

Maintenance in the UK 在英国的生活费

Confirmation of maintenance and accommodation, if necessary, from your A-rated sponsor.

如有必要，提供您的A级担保方需出具生活和住宿相关证明

If you have an A-rated sponsor which is certifying that they will maintain and accommodate you, if necessary, for your first month of employment, this must be confirmed on your certificate of sponsorship. Evidence of prospective earnings should also be entered on the certificate of sponsorship. 如果您的A级担保方证明，在必要的情况下会提供您工作第一个月的食宿，这些信息需在您的担保证书中列明。担保证书中还应填写预期收入。

A letter from an A rated sponsor certifying the maintenance of a Tier 2 migrant is not an acceptable method of certifying your maintenance. 由A级担保方出具的，证明承担第二层级（Tier 2）移民生活费的信件，不能作为您在英国生活费用的证明材料。

If your A-rated sponsor does not confirm this maintenance and accommodation, you must provide documents showing that you have had at least £945 in your account at all times over the 90 days before you apply to us. Acceptable forms of evidence are shown below. 如果您的A级担保方不能提供上述住宿及生活费证明，您需要提供文件证明，在您递交申请之前的90天里，您的账户余额在任何时段均不低于945英镑。可接受的文件类型如下。

<p>Personal Bank Statements and /or a Savings Account pass book(s) and /or a letter from bank confirming level of funds on the bank's original letter headed paper. 个人银行对账单，和/或定期存折，和/或用银行抬头纸开具的资金证明信</p>	<p>These documents should cover a period of 90 days immediately preceding, and dated no more than 31 days prior to, the date you submit the application. The balance should not fall below the required minimum of £945 at any time during the 90 day period. 资金证明材料开具日期需在签证申请日期前31天以内，且截止至递交签证申请当日，资金存期已达90天。资金余额在90天内任何时段都不能低于要求的945英镑。</p> <p>Property, shares, bonds, pension funds, life insurance or similar savings accounts are not acceptable. 房产，股票，债券，养老基金，人寿保险或类似的储蓄账户均不予接受。</p>
<p>Letter from financial institution regulated by either the Financial Conduct Authority (FCA) or the home regulator confirming funds 由英国金融服务管理局(FCA)或受当地监管机构监督的金融机构签发的资金证明信</p>	<p>The letter should state: 证明信应说明:</p> <ul style="list-style-type: none">• your name; 您的姓名;• the account number; 账号;• the date of the letter; 证明信开具日期;• the financial institution's name and logo; 金融机构名称及图标;• the funds held in your account; and 账户中的资金金额; 以及• that the funds have been in the bank for at least 90 days. 资金存期不短于90天。 <p>We will not accept letters which simply show the balance in the account on a particular day as these documents do not show that you hold enough funds for the full period required. <p>Information about you 个人信息</p>	<p>Dependants must also provide a current and valid travel document or passport, one passport sized colour photograph, evidence of their permission to be in the country where the application is made (if not a national of that country), previous passports & translations of any documents submitted that are not in English or Welsh. 家属同样需要提供当前有效的旅行证件或护照，一张彩色护照照片，进入该国家的许可文件（如果申请人不是递交申请所在国的公民），旧护照以及所有非英语或威尔士语材料的翻译件。</p>
<p>Evidence of relationship to sponsor 与担保方的关系证明</p>	<p>E.g. marriage certificate, civil partnership registration or birth certificate. 例如：结婚证，同性配偶关系证书，或出生证明</p>

Evidence of maintenance. 生活费证明

If the Tier 2 migrant is employed by an A-rated sponsor who will maintain and accommodate them and any dependants until the end of their first month of employment in the UK, you must send a letter from the sponsor which confirms this. 如果第2层级移民受雇于英国A级担保方，且该担保方承诺负担该移民及其家属第一个月在英国工作的住宿和生活费，您必须提交雇主的确认信。

Otherwise, you must provide financial evidence showing adequate support for any dependants. The statements must show additional funds of £630 per dependant in the account for at least 90 days immediately preceding the application.

否则，您必须提供其它资金材料，证明您有足够的资金资助家属的生活。所交材料需证明每个家属均有额外630英镑，并且截止至签证申请递交日，资金存期已经达到至少90天。
