## Financial Sanctions Notice

8/12/2017

### Libya

#### Introduction

1. Council Regulation (EU) 2016/44 (“the Regulation”) imposing financial sanctions regarding Libya has been amended.

#### Notice summary (Full details are provided in the Annex to this Notice)

2. The following entry has been amended and is still subject to an asset freeze:

- CAPRICORN (Group ID: 13519)

#### What you must do

You must:

- i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
- ii. freeze such accounts, and other funds or assets;
- iii. refrain from dealing with the funds or assets or making them available to such persons unless licensed by the Office of Financial Sanctions Implementation (OFSI);
- iv. report any findings to OFSI, together with any additional information that would facilitate compliance with the Regulation;

- v. provide any information concerning the frozen assets of designated persons that OFSI may request. Information reported to OFSI may be passed on to other regulatory authorities or law enforcement.
- 3. Where a relevant institution has already reported details of accounts, other funds or economic resources held frozen for designated persons, they are not required to report these details again.
- 4. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

### **Legislative details**

- 6. On 8 December 2017 Commission Implementing Regulation (EU) No 2017/2260 (“the Amending Regulation”) was published in the Official Journal of the European Union (O.J. L 324, 8.12.2017, p.39) by the European Commission.
- 7. The Amending Regulation amended Annex V to the Regulation with effect from 8 December 2017.
- 8. The Amending Regulation reflects the decisions made on 27 November 2017 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 2146 (2014) to amend 1 entity to the UN Libya list.
