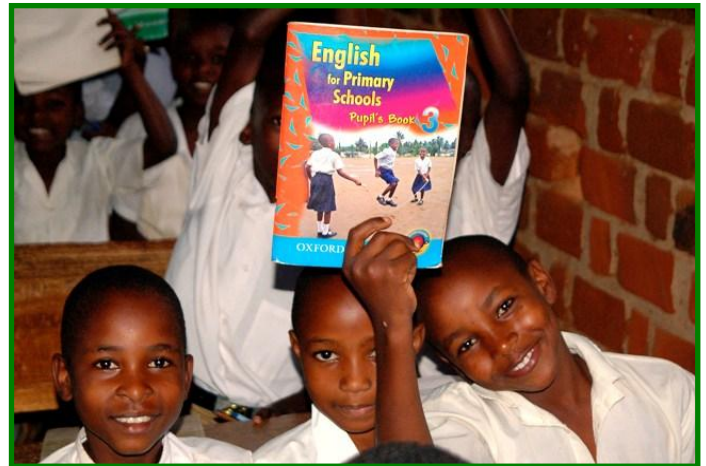


Summary of DFID's work in Tanzania 2011-2015

Updated May 2012

Why we work in Tanzania

Tanzania has made impressive development gains in the past decade with gross domestic product (GDP) growth rates averaging 7% a year from 2001 to 2009. However, this growth has largely been limited to sectors such as mining and telecoms, and has not made significant changes to income levels for most Tanzanians. 80% of the population (34 million people) live on less than £20 a month and 34% (15 million people) live on less than £7 a month, making it almost impossible to buy essential goods such as soap and clothes. Tanzania's size, poor infrastructure and a rapidly expanding population make it difficult for people to access basic services equally across the country. The Government of Tanzania's poverty reduction strategy aims to address these issues, but it has limited resources. In 2010-2011, the Government could only afford to spend £125 per Tanzanian to cover all their needs for the whole year.

Despite the challenges, good progress has been made against some of the key Millennium Development Goal (MDG) targets over the last decade. These include:

- More than 90% of children enrolled in primary school every year since 2005
- Equal numbers of boys and girls attending primary school across the country
- Child mortality reduced by 45% in 10 years since 1999
- HIV stabilised and deaths from malaria halved since 2000

The three main challenges over the next four years will be to help people rise out of poverty, improve the quality of education, and help the Tanzanian Government to improve public services.

What we will achieve

- Help 563,000 rural men and women raise their incomes
- 741,000 people (75% of them women) helped to access financial services
- 1 million women a year given access to family planning
- 650,000 people helped to cope with the effects of climate change, including floods and droughts
- 650,000 people in rural areas given access to clean water 3 million insecticide treated bednets distributed to help prevent malaria

Who we will work with

The UK's investments in Tanzania are designed so that DFID's funds are channelled in a number of ways: through the government; through partners such as UN agencies or non-governmental organisations, or directly through DFID's programmes. We will emphasise programmes that improve the lives of girls and women, key in the overall reduction of poverty

DFID will provide support and technical expertise in key areas such as public financial management to help the Government of Tanzania implement its poverty reduction strategy. We will continue to work closely with the Government, but will also work more with civil society and the private sector, in line with recommendations from the 2010 evaluation of Tanzania's country programme.

How we will work

More than ever, in the current financial climate, we have a duty to show that we are achieving value for money in everything we do. Results, transparency and accountability will be our watchwords and we are determined to get value for money for every hard-earned taxpayer pound spent on development.

In Tanzania, we will put in place a comprehensive Value for Money Strategy which will monitor and improve the value for money of our entire country programme. We will also commission independent evaluations to assess the impact and effectiveness of our programmes. We are fully committed to being transparent about UK aid spent in Tanzania, and will support the Government of Tanzania and other partners to become more transparent and accountable to the public.

Actions we will take on transparency include:

- Publishing clear, concise information about our programmes on the DFID website
- Supporting civil society and non-governmental organisations to be more transparent and to encourage Tanzanian citizens to demand greater accountability from the Government
- Encouraging the Tanzanian Government and other development partners to be more transparent to their public
