

#### 2. Reported concerns about charities 2016-17

#### 2.1 Reports of serious incidents (RSIs)

There were 2182 serious incidents reported to us in 2016-17 (2015-16: 2217). The key issues in these reports were as follows, showing the principal issue only.

We engaged with charities that had previously reported serious incidents, to seek assurances that they have since acted on the regulatory advice we had given. Of the serious incidents reported to us, 1813 (83%) were dealt with solely by our Gateway/Assessment team, 57 referred to our investigations and monitoring teams, and 311 to our Operations teams.



### 2.2 Whistleblowing reports


We dealt with 142 whistleblowing enquiries this year (2015-16: 143). They fall into three source categories

17 from auditors (2015-16: 16)
 37 from independent examiners (2015-16: 40)
 88 from employees: (2015-16: 87)

As a result we opened 109 cases. Of the Whistleblowing incidents reported to us, 20 were dealt with solely by our Gateway/Assessment team, 2 referred to our investigations and monitoring teams, and 120 to our Operations teams.



Whistleblowing incidents by category 2016-17









#### **New Powers**

During 2016/17, a number of the provisions strengthening the legal framework giving the Commission new powers to help regulate more effectively in line with public expectations came into force.

We used the updated (new or amended) powers introduced by the Charities (Protection and Social Investment) Act 2016 13 times up to 31 March 2017, including directing actions not to be taken and issuing the first notice of our intention to issue an official warning.

The total number of times we have used the new powers or those updated by the 2016 Act, at 30 September 2017 was 68:
