

NOTICE OF ORDER

HIGHWAYS ACT 1980 SECTION 119

Essex County Council

1) Public Path Diversion Order 2016 Footpath 11 Great Waltham

2) Public Path Extinguishment Order 2016 Extinguishment Bridleway 107 Great Waltham

Notice is hereby given that the above referenced Orders have been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Orders.

The **start date** for the above Orders is 24 January 2018.

Consideration of the Orders will take the form of exchanges of statements of case and comments on statements of case.

1) The effect of the Order, if confirmed without modifications, will be to divert Footpath 11 at Hill Farm in the parish of Great Waltham in the City of Chelmsford under section 119 of the Highways Act 1980.

A part length of Footpath 11 starting from grid reference 56631,217082 at its junction with the B1008 and running in a north easterly, southerly, and then generally south easterly, trajectory across a field for a total distance of approximately 710 metres to grid reference 56797,21773 where it meets Footpath 14 Great Waltham will be diverted to an alternative route commencing at grid reference 56629,21790 some 80 metres north of the existing path and running in a south easterly direction parallel to the B1008 for a distance of 560 metres to grid reference 56659,21744 where it meets with Bridleway 14.

2) The effect of the Order, if confirmed without modifications proposes that Bridleway 107 is to be extinguished as not needed for public use.

Bridleway 107 at Hill Farm commencing at grid reference 56748,21701 where the bridleway leaves the B1008 Sandon Hill travelling west across a field for a total distance of 301 metres to grid reference 56779,21701 at its junction with Bridleway 49 Great Waltham is to be extinguished as not needed for public use. The Bridleway has not existed for some years and the landowner wishes to create an alternative bridleway to link Black Chapel lane with the existing Bridleway 14.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 7 February 2018]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Orders.

Within 8 weeks of the start date [by 21 March 2018]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Orders.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Orders (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 2 May 2018]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Orders must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Orders must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.


Chelmsford City Council has been consulted and Chelmsford City Council has consented to the making of the order) as required by section 120(2) of the 1980 act.

1 The public right of way over the land at North End in the Parish of Great Waltham and shown by a bold continuous line on the map numbered GWAL 11A ("the map") contained in this order and described in Part 1 of the schedule to this order shall be stopped up after 67 days from the date of confirmation of this order.

2 There shall at the end of 60 days from the date of confirmation of this order be a public footpath over the land situate at North End in the Parish of Great Waltham described in Part 2 of the schedule and shown by a bold broken line on the map contained in this order.

MAP NOT TO ORIGINAL SCALE




PLAN NO. GWAL 11 A
