

Financial Sanctions Notice

28/02/2018

North Korea (Democratic People's Republic of Korea)

Introduction

1. Council Regulation (EU) 2017/1509 ("the Regulation") imposing financial sanctions against North Korea (Democratic People's Republic of Korea) has been amended so that an asset freeze no longer applies to the persons listed in the Annex to this Notice.

Notice summary (Full details are provided in the Annex to this Notice)

2. The entries listed in the Annex to this Notice have been <u>removed</u> from the consolidated list and are no longer subject to an asset freeze.

Legislative details

- 3. On 27 February 2018 Council Regulation (EU) No 2018/285 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 55, 27.2.2018, p.1) by the Council of the European Union.
- 4. The Amending Regulation amended Annex XV to the Regulation with effect from 28 February 2018.
