Ballot Rules and Terms & Conditions

Ballot Rules

These rules apply to the ballot process for tickets to attend the event in Amiens Cathedral on 8 August 2018.

For the purposes of the below document:

"Organiser(s)" refers to the Department for Digital, Culture, Media and Sport

"Applicant(s)" refers to the primary ticket-holder who initially enters the ballot

"Guest" refers to the named person accompanying an Applicant

- 1. Applicants must be 18 years of age or over, as of 9 March 2018, to be eligible to apply for tickets.
- 2. All Applicants must provide proof of age (both for himself or herself, and for his or her guest) to the Organiser on request.
- 3. Each Applicant may only enter the ballot once, regardless of the method of entry. Checks will be made to identify and exclude duplicate applications.
- 4. Any person who makes more than one application may, without notice, be excluded from the ballot.
- 5. Applications may only be made online or by post, using the form available on the website.
- 6. Applications for the ballot can be made from 9 March 2018.
- All online and postal applications must be received by the closing date of 16 April 2018.
 Applications received after the closing date, whether online or by post, will not be considered.
- 8. Applicants who apply online and supply an email address will receive an email confirming receipt of the application within 24 hours.
- Applicants will be notified of the outcome of the ballot by email within one month of the closing date of the ballot. If a postal application was made and an e-mail address not supplied, notification will be sent by post.
- 10. Applicants who are not initially successful will be held on a waiting list. If and when tickets become available, an offer of tickets will be sent to the next Applicants on the waiting list in the order in which the draw was made.
- 11. Each successful Applicant will be asked to confirm their attendance at the event and to provide further information about themselves and their Guest to the Organiser. The Organiser will require full details, as requested, from the Applicant for both attendees.

- 12. If the Applicant fails to confirm attendance or provide the requested information by the date specified in the request, that Applicant will be deemed to have withdrawn his or her application (either in part, if the failure relates to a Guest, or in full if the failure relates to the Applicant).
- 13. No responsibility is accepted by the Organiser for late or lost applications, and proof of sending an application is not proof of receipt.
- 14. Applicants may request that their name is removed from the waiting list at any time.
- 15. Applicants placed on the waiting list will be notified by email or post within one month of the closing date of the ballot.
- 16. Once a successful Applicant has confirmed that he/she and his/her Guest will attend, and has satisfactorily provided the further information requested, the Organiser will send the requisite number of tickets to that Applicant before the event.
- 17. An Applicant may amend a Guest's details up to June 2018, but after this time a Guest's details cannot be edited.
- 18. A Guest may only attend the event with the named Applicant. If a Guest does not arrive in the company of that Applicant, the Guest will not be permitted to enter the event.
- 19. Should a successful Applicant withdraw after the ballot has been drawn, their ticket allocation will be deleted and neither the Applicant nor their Guest will be able to attend.
- 20. If a successful Applicant or Guest is no longer able to attend or otherwise withdraws, that Applicant should notify the Organiser of the withdrawal as soon as possible. Any tickets which will not be used will be offered to the next person on the waiting list by random selection.
- 21. Tickets cannot be transferred and can be used only by the Applicant and Guest named on each ticket.
- 22. Tickets will be subject to the terms and conditions set out on the website or provided in writing to postal applicants.
- 23. The Organiser retains a discretionary right throughout to alter, amend or change the Ballot Rules and the terms and conditions of the tickets.
- 24. The Organiser reserves the right at any time to cancel, change or postpone the event or the ballot, if it deems it appropriate to do so.
- 25. Neither the Organiser nor its representatives or affiliates shall be liable for any direct or indirect loss suffered as a result of any technical failure or malfunction or any other problem with any telephone network or line, system, server, provider or otherwise which may result in any email or application being lost or not properly registered or recorded.

26. These Ballot Rules are governed by the laws of England and Wales, and any dispute arising therefrom shall be subject to the exclusive jurisdiction of the English courts.

Terms and Conditions

For the purposes of the below document:

- "Organiser(s)" refers to the Department for Digital, Culture, Media and Sport
- "Applicant(s)" refers to the primary ticket-holder who initially enters the ballot
- "Guest(s)" refers to the named person accompanying the applicant
- "Ticket-holder(s)" refers to both Applicants and Guests
- "Event area" or "site" refers to the area accessed by passing through security

ENTRY

- 1. These terms and conditions apply equally to all sites associated with the event.
- 2. Tickets to the event do not confer any right to enter France, the decision over which resides with the French Government and immigration authorities.
- 3. Applicants and their Guests will require a valid ticket to enter the site.
- 4. No child under the age of 5 will be permitted to enter the site.
- 5. All Applicants and Guests may be subject to security checks (such as a criminal record check). The Organiser reserves the right to rescind any ticket to the event at short notice without explanation if, for example, the authorities advise the Organiser that any person should not attend or if there is any concern about a person's motives or background.
- 6. Every person will be required to show a current and valid passport as proof of their identity before they will be permitted to enter the site.
- 7. Guests must be accompanied by the Applicant on entry.
- 8. No animals will be permitted, other than assistance dogs for guests with disabilities.
- 9. The Organiser may refuse anyone entry to the event at its absolute discretion, and any person who fails to comply with instructions from an official steward or other person acting on behalf of the Organiser may be refused entry or ejected. In addition, anyone found (in the opinion of the Organiser, or any person acting on its behalf) to be causing or threatening to cause damage to any part of the site, the site infrastructure, causing or threatening to cause harm to any other person at the venue or in the near vicinity, or behaving in an illegal, antisocial or aggressive manner, or appearing to be under the influence of drugs or alcohol, or in breach of these conditions, will be ejected from the site and may be reported to the police.
- 10. All terms and conditions apply for the duration of the event.

INSIDE THE EVENT SITE

- 1. The Organiser may search any person and personal property, and refuse admission to, or eject from the site, any person who refuses to be searched by an official steward, the police or any other person acting on their behalf.
- 2. Other than as may be required by the Organiser for the purposes of staging the event, the following articles are not permitted at the event flags, advertising or marketing messages, chairs, knives, fireworks, smoke canisters, air-horns, flares, weapons, dangerous or hazardous items, laser devices, glass vessels, cans, poles, and any article that might be used as a weapon and/or compromise public safety. This list represents a non-exhaustive list of the types of articles which are not permitted and the Organiser retains a discretionary right to refuse entry to, or eject any person from, the site anyone found to be carrying any of these items.
- 3. No food, alcohol or soft drinks are permitted to be taken onto the site. One small, plastic bottle of water per person may be brought.
- 4. Strictly no illegal substances will be permitted.
- 5. Original tickets should be retained at all times while on the site and must be shown to the Organiser, its representatives or the French security authorities on request during the event.
- 6. The event will be filmed, recorded and photographed and that material broadcast, transmitted and published throughout the world, including via internet streaming. By attending the event, every Applicant and Guest gives his or her permission to the Organiser and any other person to use all such material for these commemorative purposes.

GENERAL

- 1. The Organiser reserves the right at any time to cancel, change or postpone the event or the ballot if it deems it appropriate to do so. Should the event or the ballot be cancelled, postponed or changed for any reason, the Organiser will not be liable for any loss or expense incurred or to be incurred by any person, including but not limited to the cost or expenses incurred or to be incurred in relation to travel to the event and/or for accommodation in relation to the event.
- 2. Under no circumstances will the Organiser be liable for unforeseen or indirect loss of any form.
- 3. Successful Applicants and their accompanying Guests are responsible for their own costs and expenses, including travel and accommodation, relating to their attendance at the event.
- 4. Under no circumstances will the Organiser be liable for any incident occurring while travelling to or from the event. Under no circumstances will the Organiser be liable for lateness caused by delays to transport or caused by any other means.

- 5. Any person who leaves the site during the event on 8 August 2018 will not be permitted to re-enter the site under any circumstances.
- 6. The information provided in respect of Applicants and Guests when entering the ballot will be shared by the Organisers with their agents and other organisations concerned with the administration and security of the event (including security authorities in the UK and France and event management companies) and shall be used:
 - to determine eligibility to enter the ballot and attend the event; and
 - to administer the security and logistical arrangements for the event, but will not be used or passed on for marketing or commercial purposes.
- 7. Information will be kept for administrative purposes for three months after the event, after which it will be securely destroyed to ensure full, proper and appropriate administration of the event and will be treated in accordance with data protection laws in the UK.
- 8. The Personal Information Charter is applicable to all persons applying for tickets: www.gov.uk/government/organisations/department-for-culture-media-sport/about/person al-information-charter
- 9. Tickets may not be sold, traded, transferred or offered for sale and may not be used as a prize or for any other promotional or trade purpose by anyone except the Organiser. The Organiser will rescind any ticket which it reasonably believes has been sold or offered for sale, and any person attempting to use a ticket which the Organiser has rescinded or reasonably believes has been sold or offered for sale will be refused entry into the event.
- 10. Applicants must supply all information reasonably requested from time to time by the Organiser or its representatives or the security authorities in the UK or France and comply with all rules and regulations to be eligible for the ticket(s). A failure to provide any such information or comply with rules and regulations entitles the Organiser to rescind any ticket including, where the failure is attributable to an Applicant, the ticket of any Guest associated with that Applicant.
- 11. Each Applicant and Guest acknowledges that these terms and conditions of entry, together with any terms and conditions incorporated into the Ballot Rules found on the website and any other reasonable terms and conditions as may be stipulated by the Organiser from time to time, represent the entire agreement between themselves and the Organiser with respect to the event.
- 12. These terms and conditions are governed by the laws of England and Wales and any dispute arising therefrom shall be subject to the exclusive jurisdiction of the English courts.
