The statistical release found separately provides results from the Recruit Trainee Survey (RTS) 2017/18. The RTS is administered to All Phase 1 and 2 training establishments to gauge Phase 1 recruits' and Phase 2 trainees' attitude, background, perceptions and experience of training and hopes for the future. The data is used to inform colleges on their performance, and to compare results with required standards set by the MOD.

Methodology

All trainees and recruits who have completed at least two weeks training were invited to participate in the survey. Participants complete an anonymous and confidential online questionnaire.

The survey was carried out over a 12 month survey period (1 April 2017 to 31 March 2018) to bring it in-line with the military calendar. During this time there were 14,691 responses to the questionnaire. Overall, 4,964 Phase 1 Army recruits and 3,895 Phase 2 Trainees, 1,857 Phase 1 Royal Navy recruits and 1,349 Phase 2 Trainees and 1,601 Phase 1 RAF recruits and 1,004 Phase 2 Trainees completed the Survey (responses for the Royal Marines are included within the Royal Navy figures).

A detailed explanation of the statistical reliability of this survey is found in Annex A of the main report, however it should be noted that due to non-response we cannot be certain that the figures obtained are exactly those we would have found, had everybody been interviewed (the ‘true’ values).

For any percentage given ‘confidence intervals’ are estimated within which the true values are likely to fall. For example; if 10% or 90% of our sample of 8,422 Phase 1 recruits strongly agreed that the training was what they expected, we can be 99% confident that the ‘true’ value would be between 10.8% and 9.2% (if 10% strongly agree) and between 90.8% or 89.2% (if 90% strongly agree), i.e. a margin of 0.8% on each side.

Statistical Testing

As part of the continuous improvement process, the application of statistical testing was reviewed in 2017/18. The review identified that the robustness of the report could be improved by reducing the number of pairwise comparisons for each item (from 29 to 6), and by reducing the significance level (from 0.05 to 0.01). These changes were introduced for the first time this year.

Navy and Marines Integration

The approach to analysing the data for Royal Marines in Phase 1 and those in Phase 2 differ. Data for Royal Marines in Phase 1 are integrated into the Royal Navy’s figures. This means combined results are presented for response rates, and individual question items throughout the report. For Phase 2 Royal Marines, their data is not combined. Instead Royal Marine data is only included in

the *Total* figures for response rates and individual question items. This approach is currently subject to review and any changes will be introduced in the 2018/19 report.

Revisions

Corrections to the published statistics will be made if errors are found, or if figures change as a result of improvements to methodology or changes to definitions. When making corrections, we will follow the Ministry of Defence [Statistics Revisions and Corrections Policy](#). All corrected figures will be identified by the symbol “r”, and an explanation will be given of the reason for and size of the revision. Corrections which would have a significant impact on the utility of the statistics will be corrected as soon as possible, by reissuing the publication. Minor errors will also be corrected, but for convenience these corrections may be timed to coincide with the next annual release of the publication.
