This NAA presents the culmination of development activity associated with ASSC regulation and aims to establish improved links between the MOD's capability development process and the establishment of effective ASSCs. Incorporation of approved NPA 19/01 comments followed a period of sentencing, a summary of which, alongside a redacted sentencing tracker, is hosted on the MAA website.
