**Re: Consultation on proposal to increase the fee to add a prohibited type dog to the Index of Exempted Dogs**

1. I am writing to invite views on a proposal to increase the fee for an owner of an otherwise prohibited type dog to place it on the Index of Exempted Dogs, as provided under the Dangerous Dogs Act 1991.
2. The proposal forms part of the Government's package of proposals to tackle irresponsible ownership of dogs.
3. The particular proposal would apply to England and Wales and together with the other proposals within the package has already been consulted upon in England. The consultation therefore applies to Wales only.
4. The attached consultation document sets out the details of the proposal and questions we would like answers to, in order to decide whether or not to seek approval for legislative change. Also attached at annexes B is the full Impact Assessment for the proposal.
