## **Authorized Amendment**

This amendment is a complete review and rewrite of RA 2340. The RA structure has been amended to provide clarity on the AMC that apply to different categories of Passengers.

In addition, the RA now includes regulation associated with the employment of Supernumerary Crew on Air Systems that are goverened by the MAA Regulatory Publications.

The amended RA requires ADH/AM(MF) to publish orders or instructions that amplify how these regulations apply to the activity within their AoR. To ensure the Regulated Community has enough time to align subordinate orders and instructions, Issue 6 will initially be issued under a Regulatory Notice, before publication in the MRP on 1 Feb 20.
