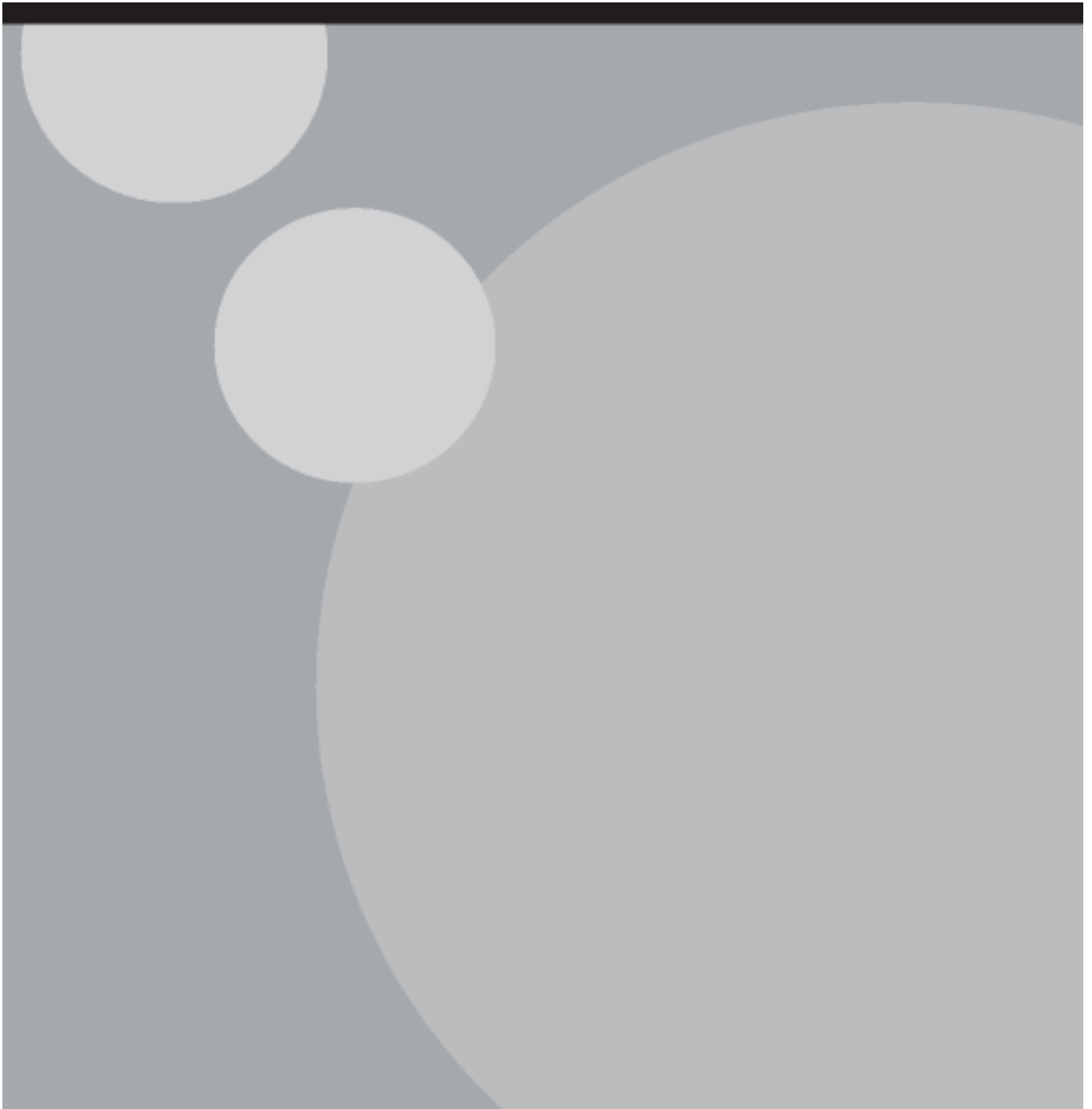

## Scope of the consultation

<b>Topic of this consultation:</b>	The appended document entitled <i>Draft Statistics Plan for 2011/12 – Consultation</i> describes our proposals for collecting and publishing official statistics over the period April 2011 to March 2012.
<b>Scope of this consultation:</b>	<p>We are seeking:</p> <ul style="list-style-type: none"><li>• users' views on the extent to which our planned deployment of resources will meet their needs for a range of official statistics covering the Department's responsibilities</li><li>• users' reactions to our proposals for either retaining; realigning; re-engineering; or curtailing our existing portfolio of official statistics products</li><li>• suggestions from existing users or potential users for the development of any new statistics, products or services</li><li>• suggestions from providers for any further reductions in the amount of data we collect and publish</li><li>• information from users about the particular uses to which they put our statistics.</li></ul> <p>The responses to this consultation will be considered alongside the submissions we received in response to the Department's earlier public consultation on the <i>Single Data List</i> where the focus was on our statistical sources and surveys.</p>
<b>Geographical scope:</b>	The majority of the department's official statistics relate to 'England'. Some of our statistical series, however, cover either 'England and Wales' or the 'United Kingdom'.

## Background

<p><b>Getting to this stage:</b></p>	<p>The proposals presented in this consultation were informed by an internal review of the Department's official statistics, and reflect the financial constraints under which all government departments are now operating as a result of the Comprehensive Spending Review.</p> <p>Many local authorities will have already conveyed their views on our data collection activities in the context of the Department's earlier public consultation on the <i>Single Data List</i>. Their earlier views will be considered alongside the submissions we receive in response to this consultation where the focus is more on our range of statistical products.</p>
<p><b>Previous engagement:</b></p>	<p>This is the first consultation of its kind. Henceforth, similar exercises are likely to be run on an annual basis.</p>

## Foreword

We are publishing this first draft of our Statistics Plan for the coming year in the context of the Department's overall Business Plan for the years 2011-15<sup>1</sup> and in accordance with the requirements set out in the *Code of Practice for Official Statistics*.<sup>2</sup>

Our Plan covers the period April 2011 to March 2012 and sets out our draft proposals for delivering statistical products and services which are intended to meet the needs of users (both internal or external); serve the public good; and match the professional standards for 'official statistics'<sup>3</sup> set out in the Code of Practice.

We will publish a final version of the Plan once we have considered, and where appropriate acted on, any submissions we receive in response to this consultation, as well as the submissions we have already received in response to the Department's earlier consultation on the *Single Data List*<sup>4</sup>.

We welcome comments and views on our Plan, and suggestions for changes, from anyone who provides data for; uses; or has a strong interest in; the Department's official statistics.

# 1. Overview of official statistics in DCLG

## Official statistics in DCLG

The statistical products and services described in this Plan will be delivered in the context of the overall vision and objectives set out in the Department's strategic Business Plan, and will be managed in a way which helps the Department to carry out its key responsibilities in each of the following areas:

- supporting local government
- housing
- planning and land use
- regeneration
- communities and neighbourhoods
- the Fire and Rescue Service.

## Legislative and policy context

The Department produces official statistics in accordance with the suite of statistical legislation that was enacted in 2007 and 2008 with the aim of enhancing public trust and confidence in official statistics, namely:

- the *Statistics and Registration Service Act 2007* which sets out the constitutional and functional arrangements that govern the production of official statistics in the UK
- the UK Government's *Pre-release Access to Official Statistics Order 2008* which sets out the principles and rules governing access to official statistics in their final form before release.

In addition, all of our statistics are managed in a way which meets the best practice standards set out in the statutory *Code of Practice for Official Statistics* published by the UK Statistics Authority - an independent body reporting directly to Parliament which is responsible for overseeing, promoting and safeguarding the production and publication of official statistics that serve the public good.

One of the Authority's key statutory functions is to 'assess' official statistics against their Code of Practice. If the Authority judges a particular set of official statistics to be fully compliant with its *Code of Practice for Official Statistics* it must designate those statistics as 'National Statistics'.



By the same token, all public bodies which produce official statistics labelled as 'National Statistics' have a statutory duty to comply with the Code, as well as with the appropriate Pre-release Access Order. Producers of statistics are also expected to ensure that all their other official statistics follow the best practice principles set out in the Code although, in the latter case, compliance is not formally assessed by the Authority.

## Management and deployment of statistical resources

As is the case with the majority of government departments in the UK, DCLG has adopted a decentralised approach to the deployment of Statisticians and their support staff. The majority of our statistical staff are bedded out in whichever administrative or policy area is responsible for the subject-matter covered by their statistics.

Over the initial period covered by this Plan, the department plans to deploy 53 staff (30.9 Whole-time Equivalents) in the specific task of collecting and producing official statistics. Of these staff, 33 (22.1 Whole-time Equivalents) are professional statisticians. As well as undertaking the purely statistical work described in this Plan, many of these staff will also carry out administrative and policy functions. The eventual deployment of these staff, and changes to their numbers over the year, will be managed in accordance with planned reductions in the Department's staffing complement consequent upon the *Department's Structural Reform Plan* (Part C of the *Department's Business Plan for 2011-2015*)

## Professionalism and accountability

All of the Department's Statisticians and their support staff are members of the Government Statistical Service – a cross-government community which forms the glue that binds the UK statistical system together. As well as being accountable to their own line-managers, DCLG statisticians are also professionally accountable to the Department's Head of Profession for Statistics and, through the Head of Profession, to the National Statistician acting in her role as the Head of the Government Statistical Service. The Department's Head of Profession has been appointed by the Permanent Secretary in consultation with the National Statistician, and is supported by the Department's Analytical Champion.

## Statistical portfolio

The Department currently publishes over 60 statistical products on either a regular or ad hoc basis using data gathered from a mixture of administrative and statistical sources. Of these, 26 (43 per cent) are designated as National Statistics products – a label which signifies that they have been judged to be fully compliant with the Code of Practice, pending a formal assessment of compliance by the UK Statistics Authority. To date, five sets of the Department's statistical products have been assessed by the Authority and, in each case, their National Statistics designation has been confirmed subject to the Department implementing a number of professional and managerial requirements highlighted by the Authority. We also publish a large range of supporting Tables to accompany some of our statistical releases/publications.

## Publication and dissemination

Users, and the public more generally, can access all of our statistical products and services, and accompanying metadata, by clicking on the 'Statistics' area of the Department's website. The Department's statistics are also accessible from the Publication Hub – a portal website administered by the Office for National Statistics which operates as the executive office of the UK Statistics Authority. The Hub provides links to all of the National Statistics published across the UK. Users who are more interested in DCLG data disaggregated to the small area level can also use the Office for National Statistic's Neighbourhood Statistics Service.

## Arms-length producers

In 2009, and in accordance with Section 6(1) of the *Statistics and Registration Service Act 2007*, DCLG ministers in the previous administration decreed that three of the non-crown bodies sponsored by the Department should also be treated as ‘producers of official statistics’ and all three were named as such in a series of Official Statistics Orders<sup>5</sup>. However, the statistical activities of these arms-length bodies have not been included in this Plan.

## 2. Key activities undertaken over the past year

### Reviews / public consultations

During the past year we launched a number of public consultations on a range of proposals that had emerged from reviews of our data collections and statistical end-products. These consultations are summarised below, along with their launch dates:

#### Statistics on land use change, commercial floor space and town centre/retail development

On 16 February 2010 we launched a seven-week consultation incorporating our proposals for changing the frequency of publication and coverage of these statistics. Our subsequent response was published on 15 October.

#### Household projections

On 1 March 2010 we launched a six week public consultation on technical changes to the methods and outputs for the household projections. Our subsequent response to the submissions received was published on 6 August. The proposed changes were adopted for the 2008-based household projections published in November 2010.

#### Place Survey

On 30 March 2010 we launched a six-week consultation designed to inform the content, guidance and outputs of the 2010 Place Survey. The decision was taken, subsequently, to cancel all further surveys in this series.

#### Indices of Deprivation

Also on 30 March 2010 we launched a six-week consultation seeking users' views on our plans for the English Indices of Deprivation. Our subsequent response was published on 28 February 2011.

## Rough sleeping statistics

On 23 July 2010 we launched a six-week consultation describing proposals for changes to our guidance on assessing the extent of rough sleeping in each area. Our response was published on 14 September 2010.

## English Housing Survey

On 13 August 2010 we launched a five-week consultation on a set of cost-savings measures proposed for the 2011/12 English Housing Survey. Our response to the submissions received was published on 16 December 2010.

## Citizenship Survey

On 1 November 2010 we launched a one-month consultation on the future of the Citizenship Survey outlining our intention to cancel future surveys once the 2010/11 survey had run its course. Our subsequent response to the submissions received was published on 17 March 2011 and incorporated the decision to cancel the Survey once the 2010/11 survey had run its course.

## Statistics on Fire and Rescue Services

On 26 November 2010 we launched a seven-week consultation seeking views on proposed reductions in the non-financial returns required from the Fire and Rescue Services. Our subsequent response was published on 18 March 2011.

## Product assessments

Throughout the year, the Department co-operated with the UK Statistics Authority by helping their Assessment Team to carry out their statutory duty to assess all National Statistics for compliance with the *Code of Practice for Official Statistics*. At the time of writing, and since its inception, the Authority has published over 100 individual assessment reports, five of which cover DCLG's official statistics. Further assessments of the Department's statistical products are either ongoing or in the pipeline. The five sets of DCLG statistical products assessed to date were:

- *Council Tax Levels in England*  
Report Number 32 published on 31 March 2010
- *Statistics on Collection rates for Council Tax and non-domestic rates in England*  
Report Number 46 published on 27 May 2010
- *Statistics from the English Housing Survey*  
Report Number 57 published on 30 September 2010
- *Local Government Financial Statistics*  
Report Number 63 published on 28 October 2010
- *English Local Authority Capital Expenditure and Receipts, and Revenue Expenditure and Financing*  
Report Number 97 published on 7 March 2011.

In each case, the Authority's Assessment Team confirmed the National Statistics status of these products on condition that the Department meets a number of management conditions.

## Contributions to wider Government Statistical Service initiatives

The Department's Statisticians and their support staff have played a full and active part in corporate initiatives across the Government Statistical Service as well as participating in, and contributing to, a number of cross-cutting Government Statistical Service committees, working groups, and the like. Prominent amongst these are the following activities:

### Office for National Statistics Survey Control Unit

The Department has continued to contribute to the work of the Office for National Statistics Survey Control Unit which is responsible, amongst other things, for implementing the Prime Minister's instructions to departments to minimise, monitor and forecast the financial cost to local authorities and businesses of responding to government surveys. The Department's efforts on this front, along with those of other departments, are chronicled in the Office for National Statistics Survey Control Unit's *Annual Report on Government Statistical Surveys of Businesses and Local Authorities*. ### Migration and population statistics

The Department worked with the Office for National Statistics and other government departments on the National Statistician's Migration Statistics Improvement Programme and also contributed funds to this initiative.

### Population Census

We worked with the Office for National Statistics to help plan the decennial Population Census which took place on 27 March 2011 and also contributed funding towards the costs of the additional questions posed in the census.

### Beyond 2011 Project

We also worked with the Office for National Statistics and other departments on a programme of work to explore the feasibility of exploiting administrative data as a future replacement for the traditional Census.



### 3. Key activities planned over the forthcoming year

#### Key strategic objectives

The activities detailed in this Plan will be implemented in accordance with the Coalition Government's strategic objectives and, in particular, the need to make departmental savings – as outlined in the Spending Review. We will also be mindful of the key strategic challenges facing the Government Statistical Service which were highlighted by the National Statistician in March 2010 in her statement headed *Statistics Matter*<sup>6</sup>. We will be particularly mindful of the Government's Transparency Agenda and will continue a programme to publish underlying datasets for each of our statistical products, subject to the necessary data protection and confidentiality requirements.

We will continue our involvement in the Single Data List initiative by reviewing and reducing the data collection burden placed on local authorities, and will maintain regular dialogue with data providers, for example through the Central and Local Information Partnership sub-committees covering housing, planning and finance.

#### Key reviews / public consultations planned

We will conduct a review of social housing and housing strategy data requirements from local authorities, in consultation with the Central Local Information Partnership housing subgroup. This will cover the Housing Strategy Statistical Appendix and Business Planning Statistical Appendix data collections (see Annex 2) and also take account of the recommendations of the Tenant Services Authority's data rationalisation review, the implementation of self-financing for council housing, and other housing policy changes.

The Department will also consider the recommendations which emerge from the National Statistician's ongoing Review of housing market statistics. The conclusions of that review are likely to be announced in May 2011.

In line with the Government's 'Transparency' agenda, and in liaison with the Fire and Rescue Services, we will pursue plans for making a Fire and Rescue Incident data set available for general public use. In so doing, we will pay due regard to data protection considerations, for example by using suitable anonymisation techniques.

## Key product assessments

Over the coming year we expect the UK Statistics Authority's Monitoring and Assessment Team to carry out further assessments of the degree to which the Department's 'legacy' National Statistics and other official statistics comply with the *Code of Practice for Official Statistics*. The current timetable for these planned assessments is shown in the Table below.

## Key contributions to wider Government Statistical Service initiatives

We will contribute as necessary to wider Government Statistical Service initiatives to develop new standards and approaches. Specific activities planned for 2011/12 include:

- Office for National Statistics -led efforts to develop a Government Statistical Service Web Dissemination Strategy
- Our continuing involvement in the final year of the cross-departmental programme to improve population and migration statistics
- Our ongoing involvement with the Government Statistical Service Transparency Sub-Group of the Government Statistical Service Presentation and Dissemination Committee which is considering how best to align the Service's policies and procedures with the Government's Transparency Agenda.

## 4. Consultation criteria

This consultation has been undertaken in accordance with the *Code of Practice on Consultation* issued by the Better Regulation Executive in the Department for Business, Innovation and Skills and in line with the Code's seven consultation criteria, which are:

1. Formal consultation should take place at a stage when there is scope to influence the policy outcome;
2. Consultations should normally last for at least 12 weeks with consideration given to longer timescales where feasible and sensible;
3. Consultation documents should be clear about the consultation process, what is being proposed, the scope to influence and the expected costs and benefits of the proposals;
4. Consultation exercises should be designed to be accessible to, and clearly targeted at, those people the exercise is intended to reach;
5. Keeping the burden of consultation to a minimum is essential if consultations are to be effective and if consultees' buy-in to the process is to be obtained;
6. Consultation responses should be analysed carefully and clear feedback should be provided to participants following the consultation;
7. Officials running consultations should seek guidance in how to run an effective consultation exercise and share what they have learned from the experience.

Representative groups are asked to give a summary of the people and organisations they represent, and where relevant who else they have consulted in reaching their conclusions when they respond. Information provided in response to this consultation, including personal information, may be published or disclosed in accordance with the access to information regimes (these are primarily the *Freedom of Information Act 2000*, the *Data Protection Act 1998* and the *Environmental Information Regulations 2004*).

If you want the information that you provide to be treated as confidential, please be aware that, under the *Freedom of Information Act*, there is a statutory Code of Practice with which public authorities must comply and which deals, amongst other things, with obligations of confidence. In view of this it would be helpful if you could explain to us why you regard the information you have provided as confidential. If we receive a request for disclosure of the information we will take full account of your explanation,

but we cannot give an assurance that confidentiality can be maintained in all circumstances. An automatic confidentiality disclaimer generated by your IT system will not, of itself, be regarded as binding on the department. ## Annex 1 Statistical theme: Local Government Finance

### 1. Users and their uses

Users	Uses
Ministers and officials in the Department for Communities and Local Government	The data are used for various purposes including informing the allocation of Grants, calculating contributions to the national non-domestic rates pool, assessing capitalisation requests and monitoring the prudential borrowing system, reserves and general expenditure and financing of local authorities.
HM Treasury	Monitoring of public expenditure to support fiscal forecasting, policy making and measuring growth.
Office for National Statistics	Compilation of the National Accounts and monthly public sector finances.
Other government departments	Most government departments use Local Government Finance statistics to monitor spend and financing for specific service areas relating to their policy area. The Department for Environment, Food and Rural Affairs, for example, use the data to monitor the cost of waste collection and disposal.
Local government	Benchmarking and cross-comparison of local authority income and expenditure.
Business and the commercial sector	This sector utilises the data to evaluate local authority expenditure patterns and to spot business opportunities e.g. consultancy work.
Opinion-formers/The media	The media are interested in a range of local government finance data including Council Tax levels, collection rates, and other aspects of local authority finance (e.g. exposure to Icelandic banks). In addition they have interest in expenditure on various service lines, reserve levels and income through sales, fees and charges e.g. parking charges.
