RA 1166 has been created to provide regulation to support the Memorandum of Understanding (MoU) between the Civil Aviation Authority (CAA) and the MAA. Where the MOD intends to utilize civil-registered Aircraft, RA 1166 will require a working group to be established to consider with elements of the MAA Regulatory Publication and Air Navigation Order will apply to the activity and decide an appropriate regulatory framework.
RA 1166 will replace RA 1127 - UK Civil Registered Air Systems Operated by the MOD. To ensure enough time for the Regulated Community to transition to RA 1166 and for the MAA to consider legacy contracts, a Regulatory Notice will also be published which allows the continued use of RA 1127 until 30 Jun 20.
