The Manual of Maintenance and Airworthiness Processes Supplement – MOD form 700 Series of Forms (MAP-02) has been replaced with the Manual of Airworthiness Maintenance – Documentation (MAM-D). This coincides with the change from MAP-01 to MAM-P. MAP-02 homepage remains for PDF reference only. The MAM-D will be in two parts: Part 1 – Governance and Guidance (a PDF document).

Part 2 – Catalogue of Forms (an online catalogue of Defence Air Environment forms).

New MAM-D homepage will be published with the following changes:

1. 37 chapters removed, five chapters retained, and five chapters established in the transition from MAP-02 Issue 18 to MAM-D Part 1. The removed chapters were either transferred to MAM-D Part 1, MOD Form 799 Series, or deleted as they held no relevant information.
2. Table of Individual MOD Form/Format Sponsor Changes (MAP-02 Chapter 0.7) has been removed as the current list of sponsors is published in the catalogue of forms.
3. Catalogue of Forms pages remain but “Chapter X.X:” has been deleted from the title/headers.
4. Addition of “Form type” as a second column to all catalogue pages and table of changes. This allows users to more easily distinguish between Posters, Forms and Formats.
5. Last Column in catalogue of forms has been renamed “Instructions for Use / Related Forms” to clarify its intended use. The links attached to the entries in this column were a consistent source of error. Although useful to the user, they are not essential so the links have been removed.
