RA 5104 – Material Specification and RA 5207 - Identification Under the NATO Codification System are to be withdrawn. RA 5104 – Material Specification - The withdrawn DefStan 05-123 - Technical Procedures for the Procurement of Aircraft, Weapon and Electronic Systems, required contractors to seek Director Royal Aircraft Establishment approval for specifications devised by them for the material of parts whose failure could affect airworthiness. It is MOD policy that neither it nor its agencies should approve specifications prepared by contractors in support of contracts awarded by MOD; consequently, this has been withdrawn. Contractors currently implementing the requirements of this section should consult the appropriate TAA. DEF STAN 00-970 PART 1/15 SECTION 3 refers to materials and their specification.

RA 5207 – Identification under the NATO codification system - This section of the DefStan contained details of extant publications. This RA was raised for completeness at the time to show that it had not been missed It was a Nul RA. DEF STAN 00-970 PART 1/14 SECTION 4 - 4.2.10 refers to the use of the NATO codification system.
