The rationale for the change is to give sufficient Regulation and GM to the ADH chain on category of device and how it is to be qualified for use. Therefore, provide a measure to hold the OEM against when procuring new devices or when upgrading existing devices. The direction in SDSR10 to uplift the balance between live and synthetic training means that FSTDs need more assurance that it meets its intended use.

The major change is the addition of a Regulation to detail the qualification process for devices and an expansion of the Guidance Material to align with ICAO and EASA Regulations wrt classification and use of Flight Simulator Training Devices (FSTD).
